Climate-Smart Agriculture & Food System Investments Secured in Climate Bond

After months of intense climate bond negotiations, on July 3, the legislature passed - with bipartisan support - the Safe Drinking Water, Wildfire Prevention, Drought Preparedness, and Clean Air Bond Act of 2024 (**SB 867**, Allen). If approved by voters in November, it will help fund a wide range of powerful climate solutions, including nature-based farming practices and investments to improve historically underserved communities' access to healthy food and safe drinking water.


Flipping the Table Podcast


