Changing Policy in Sacramento



Although there were fewer policy wins in 2019 than past years, we believe that Governor Newsom is strategically focused on food, farms and rural communities and he supported some very important wins.

Last spring ROC joined <u>CalCAN</u>'s day of advocacy in the State Capitol and helped arrange key meetings with policymakers that shape the budget. With their support and that of Governor Newsom, the groundbreaking

<u>Healthy Soils Program</u> received nearly double the funding, up to \$28 million from \$15 million in 2018. Soil building and carbon capture will accelerate. **READ MORE**

Spotlighted Ally: The Wild Farm Alliance

The Wild Farm Alliance (WFA) was founded 20 years go by Dan Imhoff, a ROC advisor and noted author on the federal farm bill and ecological farming. Dan's intention has been to bring nature back to farms because nature enhances farm and ranch resilience and as he often says, "nature also has rights." Due to the huge decline in bird populations, with 3 billion lost in the recent decades, WFA has a focus on helping agriculture develop habit for birds, many of which are excellent pest control allies. The



great conservationist and philosopher Aldo Leopold, whose work helped inspire Dan to launch WFA, said, "a thing is right when it tends to preserve the integrity, stability and beauty of the biotic community. It is wrong when it tends otherwise." WFA is helping agriculture to support biotic communities. As a member of the board of the <u>Wild Farm Alliance</u>, I invite you to have a look at the Wild Farm Alliance website and to become a contributor for the next three years as it begins to scale up its important work.
