#### Flipping the Table Features a Leader for our Time

In our latest podcast, Kat Taylor, noted holistic thinker, <u>banking entrepreneur</u>, grass-finished <u>beef producer</u> and <u>philanthropist</u> offers incisive comments that reveal a powerful intellect and welcome vision for our democracy and world. Responding to a series of questions about her life and work, Kat offers honest and hard-hitting statements related to socially responsible banking; reckoning with our nation's violent history; why those "who have the power to change the status quo rarely use it;" how she went from vegetarian to grass-finished beef producer; where her husband, presidential candidate <u>Tom Steyer</u>, targets his political contributions to reinvigorate democracy.



There are many moments in the interview that we applaud and believe you will too. Two really struck us. When talking about philanthropy, she said, "I don't see any point in perpetuating institutions that think they are going to outlive climate disaster and social chaos." And later, when asked why, given her busy life, she accepted the chair of the Advisory Board of the <u>UC Davis Agricultural Sustainability Institute</u>, she said, "I want to be part of the new research agenda that could dismantle industrial ag and give us something that is scaled enough to meet the needs of food production in our time...but do it in a way that's ecologically and financially sustainable and has equity at its heart." It is a fascinating and inspiring conversation, one we'd appreciate hearing from the next First Lady or a President.







# **Sugary Beverage Tax Campaign Rises** from the Ashes

We are committed to continuing the struggle to pass a sugary beverage tax to protect our kids and communities from preventable diseases and other health



disparities. There are rumors afloat that the beverage industry is in talks with the Governor to pass a super low tax that would not sufficiently fund prevention programs like better school food, more nutrition incentives and education and community food projects that build the food sovereignty of underserved communities. With the

help of frontline community members, legislators could craft a tax measure that ensures that clean and affordable water is conveniently accessible everywhere, and a wide array of community-desired prevention actions are included. The future health and resilience of California requires that state legislators cut their ties to BIG SODA money.

For the third year running, Slow Food USA is mounting Slow Food Nations, a celebration of America's diverse food communities in Denver. Colorado. ROC leader and Flipping the Table host, Michael Reid Dimock, was an international leader of Slow Food from 2000-07. He maintains links to and collaborations with the organization.
